India - Charge Band 16 charges apply to BT Chargecard, BT Direct (excluding incoming collect calls charged to a UK telephone number), Country to Country, Operator controlled calls and Creditcall Calls. Band 16a charges apply to other services. Operative Date:17.01.2005

Cyprus - Calls to Northern Cyprus (numbers beginning with 0090) are charged at Charge Band 3 rate.

Japan & Malaysia - Charge Band 11 charges apply to BT Chargecard, BT Direct (excluding incoming collect calls charged to a UK telephone number), Country to Country and Creditcall Calls. Band 3 charges apply to other services. Operative Date:17.01.2005

Hong Kong - Charge Band 7 charges apply to BT Chargecard, BT Direct (excluding incoming collect calls charged to a UK telephone number), Country to Country and Creditcall calls. Band 6 charges apply to other services. Operative Date:01.03.2004
